2026–2027 BROADWAY SEASON STAMP CARD SWEEPSTAKES

OFFICIAL RULES AND REGULATIONS

No Purchase Necessary to Enter or Win. A Purchase Will Not Increase Your Odds of Winning.

1. SPONSOR

The Bushnell Center for the Performing Arts (hereinafter “Sponsor” or “The Bushnell”), 166 Capitol Avenue, Hartford, CT 06106.

2. SWEEPSTAKES DESCRIPTION

The Bushnell Center for the Performing Arts 2026–2027 Broadway Season Stamp Card Sweepstakes (the “Sweepstakes”) is a promotional sweepstakes related to the bona fide sale of goods and services offered by the Sponsor. Participants who collect one (1) official stamp for each of the eight (8) Broadway productions in The Bushnell’s 2026–2027 Broadway Season and submit their completed Stamp Card will be entered for a chance to win the prize described herein.

3. SWEEPSTAKES PERIOD

The Sweepstakes begins on Monday, September 28, 2026 (“Start Date”) and ends on Sunday, June 6, 2027 (“End Date”) (collectively, the “Sweepstakes Period”). Completed Stamp Cards must be submitted no later than Monday, June 21, 2027 at 5:00pm ET to be eligible. The winner drawing will take place on or about Monday, June 28, 2027.

All dates and times are Eastern Time (ET). The Sponsor reserves the right to extend or modify the Sweepstakes Period with appropriate notice.

4. ELIGIBILITY

The Sweepstakes is open only to legal residents of the State of Connecticut who are eighteen (18) years of age or older at the time of entry. Void where prohibited by law.

The following individuals are NOT eligible to enter:

- Employees, officers, directors, and agents of The Bushnell Center for the Performing Arts;

- Members of the immediate family (defined as spouse, parent, child, sibling, and their respective spouses, regardless of where they reside) of any such employee, officer, director, or agent;
- Members of the same household (whether related or not) of any such employee, officer, director, or agent;
- Any person whose participation would be prohibited by applicable law.

5. HOW TO OBTAIN A STAMP — NO PURCHASE NECESSARY

A purchase is not required to obtain a stamp or to enter this Sweepstakes.

Participants may obtain one (1) official stamp per qualifying Broadway production during the Sweepstakes Period using either of the following methods:

Method A: Ticket Holders (Attending a Performance)

Patrons who have purchased a ticket to a qualifying Broadway production may obtain their stamp at any of the following locations on the day of a performance:

- The Bushnell Box Office
- The Customer Relations table (available on performance days)

Method B: No-Purchase Entry (Free Stamp Without Attending)

No purchase or ticket is required to obtain a stamp. Any person meeting the eligibility requirements above may obtain a stamp for any qualifying Broadway production at no cost, at no obligation to purchase, and without attending a sales presentation, by visiting The Bushnell Box Office during the following hours during the calendar week in which each Broadway production is scheduled to perform:

Weekday Hours (Monday through Friday):

- 10:00 a.m. – 5:00 p.m.

Weekend Hours (Saturday and Sunday):

- Beginning two (2) hours prior to the scheduled curtain time for that day's performance through curtain time.

Stamps are available beginning the Monday of the calendar week each Broadway production performs and through the final performance of that production's engagement. **Only one (1) stamp per production per participant will be issued, regardless of the number of performances attended or Box Office visits made.**

The Box Office is located at The Bushnell Center for the Performing Arts, 166 Capitol Avenue, Hartford, CT 06106. Participants are not required to attend a sales presentation, purchase any goods or services, or make any payment of any kind to obtain a stamp under Method B.

6. STAMP CARD

Upon first requesting a stamp, participants will receive an official Bushnell 2026–2027 Broadway Season Passport Stamp Card (the “Stamp Card”). Participants are responsible for retaining their Stamp Card. Lost or damaged Stamp Cards will not be replaced. The Bushnell is not responsible for lost, stolen, or damaged Stamp Cards.

Each Stamp Card contains eight (8) designated spaces, one for each qualifying Broadway production in the 2026–2027 Broadway Season. Stamps must be received from official Bushnell staff only. Reproduced, forged, altered, or illegible Stamp Cards are void.

7. QUALIFYING BROADWAY PRODUCTIONS

The following eight (8) Broadway productions constitute the qualifying productions for the Sweepstakes:

- *The Great Gatsby*, September 29 – October 4, 2026 (stamps also available on Monday, September 28, 2026)
- *Mamma Mia!*, October 20 – 25, 2026 (stamps also available on Monday, October 19, 2026)
- *BOOP!© The Musical*, November 10-15, 2026 (stamps also available on Monday, November 9, 2026)
- *Alicia Keys’ Hell’s Kitchen*, December 8-13, 2026 (stamps also available on Monday, December 7, 2026)
- *Maybe Happy Ending*, February 16-21, 2027 (stamps also available on Monday, February 15, 2027)
- *Waitress*, March 30 – April 4, 2027 (stamps also available on Monday, March 29, 2027)
- *Operation Mincemeat*, May 4-9, 2027 (stamps also available on Monday, May 3, 2027)
- *The Outsiders*, June 1-6, 2027 (stamps also available on Monday, May 31, 2027)

In the event a production is cancelled, postponed, or otherwise removed from the season, The Bushnell reserves the right to substitute a replacement production or to

adjust the total number of stamps required for entry. Any such modification will be announced at bushnell.org and posted at the Box Office.

8. HOW TO ENTER

To enter the Sweepstakes, a participant must:

1. Collect one (1) official stamp for each of the eight (8) qualifying Broadway productions (see Section 5 for how to obtain stamps);
2. Ensure their completed Stamp Card bears all eight (8) valid stamps; and
3. Submit their completed Stamp Card in person or by mail to The Bushnell Box Office (mailing address: 166 Capitol Avenue, Hartford, CT 06106), no later than Monday, June 21, 2027 at 5:00pm ET.

Limit: One (1) entry per person. Multiple entries from the same individual will be disqualified. Entries submitted by third parties, agents, or on behalf of another individual will not be accepted.

9. PRIZE

Grand Prize (One Winner):

Two (2) subscription seats to The Bushnell Center for the Performing Arts 2027–2028 Broadway Season, valued at up to Two Thousand Dollars (\$2,000.00 USD) (the “Approximate Retail Value” or “ARV”).

For current subscribers: If the winner is an existing Bushnell subscriber to the 2027-2028 season at the time of the drawing, the winner will receive a refund of their current subscription purchase price, up to a maximum of Two Thousand Dollars (\$2,000.00 USD). The refund will be applied to the payment method used for the original subscription purchase. The refund constitutes the entirety of the prize for current subscribers.

For non-subscribers: If the winner is not a current Bushnell subscriber at the time of the drawing, the winner will receive two (2) 2027–2028 Broadway Season subscriptions, with a combined value up to Two Thousand Dollars (\$2,000.00 USD). Specific seat locations and subscription package will be determined by The Bushnell based on availability.

Important Prize Notes:

- The prize has no cash value except as described above for current subscribers.

- The prize is non-transferable and may not be substituted by the winner.
- The Bushnell reserves the right to substitute a prize of equal or greater value if the described prize becomes unavailable.
- The winner is responsible for all applicable federal, state, and local income taxes on the prize.
- Because the prize value exceeds \$600.00, The Bushnell is required by federal law to issue IRS Form 1099-MISC to the winner. The winner may be required to provide a valid Social Security Number or Tax Identification Number prior to receiving the prize.

10. ODDS OF WINNING

The odds of winning depend upon the total number of eligible completed Passport Stamp Cards received during the Sweepstakes Period. Only one (1) prize will be awarded. The greater the number of eligible entries received, the lower each individual's odds of winning.

11. WINNER SELECTION AND NOTIFICATION

One (1) winner will be selected in a random drawing from all eligible completed Stamp Cards received by the submission deadline. The drawing will be conducted on or about Monday, June 28, 2027 by a representative of The Bushnell Center for the Performing Arts or a designated third party.

The potential winner will be notified by telephone and/or email using the contact information provided at the time of Stamp Card submission. If a potential winner cannot be contacted within five (5) business days of the first notification attempt, or fails to respond within the time specified, the prize may be forfeited and an alternate winner may be selected from remaining eligible entries.

The winner will be required to execute and return an Affidavit of Eligibility, Liability Release, and (where permitted by law) a Publicity Release within ten (10) days of receipt. Failure to timely return completed documents may result in disqualification and forfeiture of the prize.

12. PUBLICITY

Except where prohibited by law, by accepting the prize, the winner consents to the use of their name, city, state, and likeness by The Bushnell Center for the Performing Arts

for promotional and advertising purposes in any media, worldwide, without additional compensation.

13. GENERAL CONDITIONS

- The Bushnell reserves the right to cancel, suspend, or modify the Sweepstakes if any fraud, technical failure, or other factor beyond The Bushnell's reasonable control impairs the integrity of the Sweepstakes, as determined by The Bushnell in its sole discretion.
- All entries become the property of The Bushnell and will not be returned.
- The Bushnell is not responsible for lost, late, misdirected, damaged, incomplete, or illegible Stamp Cards.
- By participating, entrants agree to be bound by these Official Rules and the decisions of The Bushnell, which are final and binding in all matters relating to this Sweepstakes.
- This Sweepstakes is subject to all applicable federal, state, and local laws and regulations.
- This Sweepstakes is void where prohibited or restricted by law.

14. LIMITATION OF LIABILITY

To the fullest extent permitted by law, The Bushnell Center for the Performing Arts, its officers, directors, employees, agents, successors, and assigns shall not be liable for any injuries, losses, or damages of any kind arising from participation in this Sweepstakes or the acceptance, possession, or use of any prize.

15. DISPUTES

Except where prohibited, all disputes arising from or relating to this Sweepstakes shall be governed by the laws of the State of Connecticut, without regard to conflict of law provisions, and shall be resolved exclusively in the state or federal courts located in Hartford County, Connecticut.
